- IMPORTANT INFORMATION.

1. The affiliation is free of charge.
2. Applications from the NGB or Masters/Veterans authorised in writing from their NGB in countries where there is no existing WMA affiliate, are automatically accepted.
3. Applications from standing affiliates are automatically accepted. If an application from the same country is presented by the NGB , Masters/Veterans authorised in writing by the NGB or other independent Masters/Veterans, procedures under sections 3 (e) or 3(f) of the Constitution will be implemented.
4. WMA warmly recommends eventual applicants not officially recognised by their NGB , to contact it prior to present their affiliation form.
5. All those duly filling up the application form and responding to all WMA Constitutional requirements, will get in return a confirmation of validity of the affiliation until 31st December 2002, a complimentary ~ copy of the WMA Handbook, a statement regarding the number of voting delegates they are entitled to the forthcoming Puerto Rico General Assembly, July 2003. They are also entitled to regularly receive from the WAVA Secretary information on the activity, reports of meetings, agenda and directions to participate to the General,Assembly.
6. The signature of the affiliation and the status of WMA affiliate imply full knowledge and acceptance of the WMA rules and bye-laws.
